

JANUARY 1978

At the January meeting of the Hartford City Board of Trustees, Vice-President, Del Lord opened the meeting with the reading of the minutes. Molly made a motion to approve the minutes with Melva Doris seconding them. Ed made a motion to pay claims #2839-2890. Parky second the motion.

The December tax draw was received in the amount of \$22,790.15. This includes \$1822.49 from Licking Township. A 90 day \$10,000 investment c-d was purchased. Also a 12-month c-d for \$6600 to be held in the improvement fund was purchased. This represents the current \$4400 c-d which matured January 15th, plus \$200 accumulated interest and \$2000 budgeted for this purpose in 1978.

Jackie made a motion to pay a state unemployment tax of 1% of wages paid to staff members who earn at least \$6,000 per year. Ed second the motion.'

Parky and Ed opposed the motion. Del was unable to vote but would have cast a nay vote if he could have voted. Jackie second the ALSA motion.

Ed made a motion to add \$1242.80 to #72 account. Melva Doris second it.

Ed made a motion to adjourn and Parky again second it.

June 1978

The regular meeting of the Hartford City Library Board was called to order by President Foust. The minutes were read and approved. Claims were also read and approved, in the amount of \$4,431.23.

Mr. Horrom of Bonham Insurance Agency discussed the insurance coverage of the library and the general consensus was that the building and contents were under insured. At present the building and contents are insured for a total of ~~\$239,~~ \$266,299 and Mr. Horrom was to have his company's engineering department to make a new appraisal of the property. Other insurance to be checked were the policies covering the zerox machine, boiler and machinery, plate glass, stained glass window and the outside entry doors. Filed copies are available at the library.

Plans were discussed for the 7<sup>th</sup> anniversary of the building.

Circulation for the previous month was checked and a healthy increase was noted.

On the advice of Bill Groves a dehumidifier was purchased to solve the problem of condensation in the basement, the matter being taken care of by Mr. Lord. The janitor will be asked to clean out the gutters.

The fire extinguishers were weighed in the balance and found wanting and Mrs. Dolan was named to take care of the matter. Efforts will be made to acquaint the library staff as well as the board of trustees to understand the know how of handling an extinguisher in case of a fire.

Mrs. Jernigan told the board of need for shelving for paperback books and was instructed to investigate whether modular shelving or built in shelving would be the answer.

The matter of the small water fountain was discussed but nothing definite decide.

Mrs. Jernigan was instructed that she could attend the ALSA meeting in Chicago and would be reimbursed the \$15.00 registration fee.

Miss ~~Musser~~ Musser and Mrs. Goetz gave a report on the recent ALSA meeting held in Muncie.

Mrs. Foust announced her committees for the year. They are, House Committee, Ed Holcombe, Joan Stanley and Del Lord, chairman; book committee, Howard Parkinson and Molly Dolan, Chairperson; policy committee, Melva Doris Peterson, chair person and the library staff to start in January and present to the full board in March for approval of changes; publicity, Mrs. Jernigan will assign a staff member to type a book list once a week for the newspaper.

Present were Mrs. Foust, Mrs. Peyerson, Mrs. Stanley, Mrs. Dolan, Mr. Lord. Mr/ Parkinson with Mr. Holcombe being absent by virtue of his hiatus in far off Greece.

In the absence of President Foust, the July meeting of the Hartford City Public Library Board was called to order by Vice-President Peterson. Minutes of the last meeting were read and approved. It was noted that circulation had greatly increased in the children's area. Claims totaling 16,782.66 were read and approved. A motion to pay was made by Holcombe and seconded by Lord. It was also noted that the June tax settlement had been received, amounting to \$26,282.39, and that \$10,000.00 of this money had been invested in a 90-day C-D.

A discussion was held concerning a musical program to be held in the backyard of the library in August, as part of the 75th Anniversary celebration of the Library. It was decided that the librarian would find out what type of music is available and make arrangements.

Librarian Jernigan presented a budget for approval. A tentative agreement was made to increase salaries by 5% across the board.

Holcombe made a motion to adjourn, seconded by Parkinson.

August 9, 1978

The regular meeting of the Hartford City Public Library Board was called to order by the Vice-president, Mrs. Peterson. Minutes of the last meeting were read and approved. Claims were read, and Mrs. Dolan made a motion to pay the bills in the amount of \$4,394.39. Seconded by Mrs. Stanley. It was noted that the State Distribution to Libraries check had been received in the amount of \$1418.60.

A resolution was read and passed, to transfer \$300 in funds from Appropriation #71 to Appropriation #25.

Mrs. Jernigan suggested that the regular meeting for September be held on Sept. 6 rather than Sept. 13. The meeting can then serve as the public meeting for adopting the budget for 1979. Mr. Lord motioned that this be done, seconded by Mr. Parkinson.

Further plans were discussed for the outdoor concert, which is to be held on Sunday, August 27 in honor of the library's 75th anniversary. The Countdowns have been engaged to play for it. Mr. Ervin suggested that the concert be held in front of the library, and he is to ask the mayor to close the block to traffic.

Vice-president Peterson announced the resignation of Board President Jacqueline Foust. Mrs. Foust is planning to take two graduate classes at Ball State this fall, and will not have time for her duties as a board member. Mrs. Peterson asked to decline the presidency in view of her short tenure as a board member. Mrs. Stanley then nominated Mr. Lord as president, and was seconded by Mrs. Dolan.

Librarian Jernigan announced that one of the two CETA girl employees had left to take another job, and the second girl can only work until August 25 under the CETA summer program. Mrs. Jernigan would like to hire her part-time during vacations. The Board gave its permission.

It was noted that insurance on the building and its contents is still in line, according to Herb Horrom of the Bonham Agency.

Members present were Mrs. Peterson, Mrs. Dolan, Mr. Lord, Mr. Parkinson, and Mrs. Stanley. In the absence of Mr. Holcombe, Mrs. Stanley served as Secretary.

The regular meeting of the Hartford City Public Library was called to order by President Del Lord. New member Mrs. Joyce Needler was welcomed. Mrs Needler had been appointed by Judge Bruce Bade to fill the unexpired term of Jacqueline Foust. Minutes of the August meeting were read and approved. Claims in the amount of \$4,136.87 were read, and Ed Holcombe motioned that they be paid, seconded by Joan Stanley. It was agreed that wood purchased for constructing a bandstand for the outdoor concert last month be sold to the Enlisted Men's Club, as the library had no further use for it.

A letter from Bonham Insurance agent Herb Horrom was read, stating that the value of the library building and furnishings had risen by \$82,000. This would increase the yearly premium by \$213, and the library plant would now be valued at \$184,500. Joan Stanley motioned to increase coverage according to these terms, seconded by Joyce Needler.

President Del Lord appointed to the Art Committee Joyce Needler and Melva Doris Peterson, in addition to Mrs. Dolan and Mrs. Stanley. They will select art prints budgeted for this year.

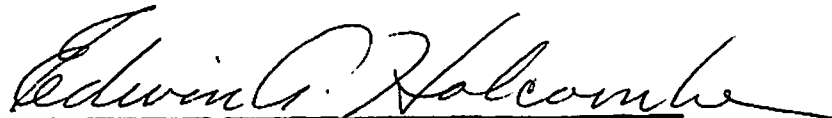
Librarian Jernigan discussed the need for another telephone extension. The library staff will discuss the location for it and report to the Board.

It was reported that a 90-day investment C-D in the amount of \$10,000 had matured and was returned to the Operating Fund, with interest of \$135.62.

Librarian Jernigan reported on the State hearing on the 1979 budget, which she and Mr. Lord attended. A hearing on the library's appeal for an excessive levy was held at the same time. The appeal was not turned down, but was not granted either. It must await further action by members of a Board drawn from the General Assembly at Indianapolis.

The new telephone extension is to be installed at the front desk.

Mr. Parkinson suggested that Librarian Jernigan attend the ILA-ILTA Conference to be held at Indianapolis November 2 - 4. This was unanimously approved.

Mrs. Jernigan is to call George Parker to check the roof and repair it if needed; also to arrange for plastering where needed, after the roof is repaired.

A motion to adjourn was made by Ed Holcombe, seconded by Howard Parkinson.

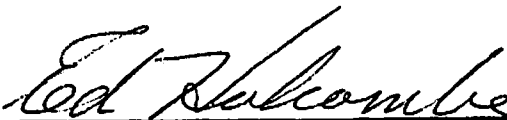
It was noted that the semi-annual check for Certified Shares and Property Tax Replacement Credit had been received in the amount of \$4709.50.



A Board of Finance is to be set up to consider proposals from local banks to act as depositories for library funds. The present Board officers, President Del Lord, Secretary Ed Holcombe, and Treasurer Molly Dolan will serve in the same capacities as officers of the Board of Finance.

Seconded by Needler, Mrs. Redmond's Bridge Club will also present a book in her memory. Also, the Redmond family has given a check to the library for \$60, money received by them from her friends. This money will be used to pay for one of the new art prints just received, and will be inscribed as a memorial.
